### TERMS AND CONDITIONS

1. The Senior Citizen must personally appear and apply for the MMWD Senior Citizen Utility Discount at the MMWD Main Office.
2. A Five Percent (5%) Utility Discount on water is granted to the Senior Citizen applied to the monthly consumption not exceeding thirty cubic meters (30 m<sup>3</sup>). Excess of the 30 m<sup>3</sup> consumption shall be computed based on the regular water rates.
3. The MMWD Senior Citizen Utility Discount is valid for new or old service connections; Provided that the service connection should be registered in the name of the Senior Citizen and the same shall be a resident of the household regardless of the number of Senior Citizens residing therein.
4. The MMWD Senior Citizen Utility Discount is only applicable to a residential service connection.
5. The Senior Citizen or its representative must pay to the MMWD Main Office to avail an outright discount.
6. The application for MMWD Senior Citizen Utility Discount shall be valid for a period of one (1) year only. An annual renewal of the application is required.
